Subject: Opposition to Potential Change in MCPS Spring Break Schedule

Dear [Superintendent and Board of Trustees,

I am writing to express my concerns regarding the recent questionnaire proposing a change to Missoula County Public Schools' (MCPS) Spring Break schedule, potentially severing its alignment with the University of Montana's academic calendar. Such a change would have significant and detrimental effects on our students, families, and the broader Missoula community.

As a university town, Missoula is deeply interconnected with the University of Montana (UM). Many families within the MCPS district have parents, guardians, or older siblings who either work at or attend the university. Aligning the school district's Spring Break with UM's schedule ensures that families can coordinate time together, reducing the burden of missed instruction and the need for alternative childcare arrangements. If MCPS were to adopt a separate Spring Break, families with ties to the university would be forced to navigate conflicting schedules, resulting in unnecessary stress, logistical challenges, and, most concerning, an increase in student absences.

Children whose parents work or study at UM would likely miss additional days of instruction if their families opt to travel during the university's break, as many already have academic and professional obligations tied to that calendar. This misalignment would disproportionately affect students in families with university affiliations, forcing them into difficult decisions between education and family needs. The consequences could be particularly harmful for younger children who rely on the consistency of their school schedules, as well as older students whose academic progress could be impacted by excessive absences.

Beyond the practical implications for families, maintaining alignment with UM's Spring Break reinforces Missoula's identity as a university-centered community. A key part of our town's culture and economy is the close relationship between MCPS and the University of Montana, and a schedule change would erode this connection. Many high school students also participate in UM programs, dual enrollment courses, and extracurricular activities that benefit from a shared break. Disrupting this synchronization would create unnecessary barriers for students who seek enrichment opportunities through the university.

Additionally, a split schedule would create challenges for educators and school staff who may also have obligations at the university. Faculty and staff members who have children in MCPS would face increased difficulties in balancing work and family responsibilities, potentially affecting retention and overall job satisfaction among district employees.

For decades, MCPS and the University of Montana have operated in tandem, reflecting the symbiotic relationship that strengthens our local institutions. While it is understandable that scheduling considerations evolve, any decision to change the academic calendar should prioritize the best interests of our students, families, and educators. Maintaining the current alignment of MCPS Spring Break with UM's schedule is not only a matter of convenience but a fundamental support structure for the many families who rely on it.

I urge you to consider the broader impact of this decision on our community and to preserve the long-standing alignment of Spring Break schedules. I appreciate your time and commitment to ensuring the best possible outcomes for our students, and I look forward to your response on this matter.
