I am writing as concerned member of the community regarding the recent accidents involving children struck by motorists on Phillips Street. These incidents are deeply alarming, and the proposed response—requiring students and parents to walk an additional block to a single crossing guard—is simply not an acceptable solution.

This approach does not address the immediate safety risks facing our children. Delayed action by MCPS and the City, coupled with a lack of response to the significant increase in traffic on Phillips, continues to put residents—especially our most vulnerable—at serious risk. Phillips Street has long been used as a cut-through to the Northside, and while future traffic-calming measures such as roundabouts are being discussed, our community needs immediate, practical interventions now.

Currently, large groups of students are entering the school at an intersection that now also includes a bus stop—but without any dedicated traffic safety infrastructure. Redirecting children to cross farther down the street fails to protect them and adds unnecessary hardship to families.

At a minimum, I urge the immediate placement of a crossing guard at this intersection during drop-off and pick-up times. I also believe that assigning Police Officers to regularly monitor Scott and Phillips Streets during peak hours would significantly improve safety and demonstrate proactive commitment to this neighborhood.

The unsafe speeds and dangerous behavior of drivers on these roads pose a clear and present danger. We urge you to act swiftly and decisively to protect the safety and well-being of our community.

This area includes one of the busier parks in Missoula, meaning pedestrian activity is high and the risk of vehicle collisions is even greater. In the past year alone, I have personally witnessed three pedestrian-versus-vehicle accidents, further underscoring the urgent need for intervention.

Additionally, visibility on Phillips Street is dangerously poor due to its narrow layout and the availability of on-street parking on both sides. These factors significantly limit motorists' ability to see pedestrians-especially children-and react in time to prevent accidents. This issue is compounded by increased traffic flow, making it clear that existing conditions create an unsafe environment for everyone.
