



Notice of Election: Missoula County Public Schools

Notice is hereby given that on May 6, 2025, a School & Special District Election will be held by mail ballot in the following districts:

School Districts:

- Missoula County Public Schools Elementary District #1
 - General Fund Levy
 - Trustee Election-3 year term (choose 3)
- Missoula County Public Schools High School District #1
 - General Fund Levy
 - School and Student Safety and Security Building Reserve Fund Levy

Ballots mail to all active and provisional voters on April 16, 2025, and are due by 8:00 p.m. on May 6, 2025. Inactive voters may request a ballot before 12:00 p.m. May 6, 2025, with the Missoula County Elections Office. Please visit the Secretary of State's My Voter Page ([MyVoterPageMT.com](https://myvoterpage.mt.gov)) to check your voter registration status.

Absentee ballots for the May 6, 2025, School and Special District Election may be acquired at the Elections Center at 140 N Russell Street weekdays between 8:00 a.m. and 5:00 p.m. from April 16, 2025, and **until noon** on Monday, May 5, 2025.

Voters who miss the Close of Registration deadline may late register for the School & Special District Election at the Elections Center (140 N Russell Street, Missoula, MT 59801) from April 8, 2025, through noon on May 5, 2025.

Same day voter registration will be available at the Missoula County Elections Center (140 N Russell Street, Missoula, MT 59801) from 7:00 a.m. until 8:00 p.m. on May 6, 2025.

On Election Day, drop off locations open at 7:00 a.m. and will remain open until 8:00 p.m.
